The Board Finance Committee met on Thursday, December 9, 2021. The agenda included approval of the minutes of the September 10, 2021 meeting, and review of the 2021/22 District, Foundation and Bond audit reports for recommendation to the Board of Trustees.

The committee approved the meeting minutes from the September 10, 2021 meeting, with a correction to indicate those in attendance who are guests.

The remainder of the agenda consisted of reviewing the 2020/21 audit reports for the District, the SRJC Foundation, the Measure H General Obligation Bond performance and financial audits, and the District required communications. Senior Manager, Aspen Cloud Hall, and Shareholder Peggy Vande Vooren of Gilbert Associates, the firm contracted to conduct the external audit of the finances and fiscal reporting of the District, went through the audit documents, highlighting the various changes and other noteworthy items and answering questions that arose. There were no audit findings and all of the audits received an unmodified opinion, which is the best possible opinion.

A recommendation that the Board Finance Committee reconsider the circumstances of the currently declared state of emergency and determine because of the possible spread of the

COVID-19 virus, that virtual meetings be continued.

Background

New state law adopted by the Legislature and signed by Governor Newsom (AB 361) allows local agencies to continue to meet by teleconference so long as a declared state of emergency exists and that, as a result of that emergency, it is determined that meeting in person would present imminent risks to the health or safety of attendees. In addition, on September 24, 2021, Sonoma County Public Health Officer issued social distancing recommendations for public meetings, available at https://socoemergency.org/recommendation-of-the-health-officer-public-meetings/.

To address this, the Board Finance Committee, by a majority vote, can take action to meet via teleconference to avoid meeting in person and therefore reduce imminent risks to the health and safety of members of the public. The law requires that this action must be reconsidered every 30 days.

The Board Finance Committee is requested to consider if the current declared state of emergency still creates an imminent risk to the health and safety of attendees, and if so, declare that it intends to meet via teleconference for the Board Finance Committee meeting, and continue to do so every 30 days until such time as local health authorities recommend eliminating social distancing recommendations and mask requirements in indoor settings, it is deemed safe to return to in person meetings, or there is no longer a declared state of emergency. This will allow the Board Finance Committee to continue to conduct its meetings via Zoom and teleconferencing without violating the public participation requirements of the Brown Act. These actions are solely for the purpose of determining continuation of Board Finance Committee meetings via teleconference, and not for the purpose of lifting the declared state of emergency related to remote instruction and services.
