  - Kate shared with the group the email that was sent from College Council regarding the Update and Outcome of the Participatory Governance Structure and Committee Alignment that College Council has been working on this year (attached). In the email, it was noted that DAC would be dissolved with the governance related work going to two other District committees and the remainder going to the appropriate operational area.
  - The committee discussed the results and shared some concerns. The committees absorbing the work of DAC are the Textbook & Instructional Materials committee and the Information Technology Group (ITG).

Some concerns about representation on the committees. Kate shared that Alia would be on both committees and the committee discussed some additional recommendations for each committee. (KJ NOTE – these recommendations were approved by College Council and incorporated into the governance structure) There was some concern mentioned about the Digital Accessibility not getting the time and attention it needs. Also, there was concern about the progress with the ACMM. It was suggested this group could possibly become a Workgroup or Subcommittee, which would need to go through the governance creation process.

  - Yes, as the District is converting all policies and procedures to CCLC format, some current policies and procedures that are not required are being eliminated.

Dear Kate,

You are receiving this email as the chair of District Access Committee.

As you know, the College Council has been evaluating our governance structure to improve clarity and create a more cohesive decision-making process. The purpose of this email is to share an overview of the proposed new structure, including recommended changes to individual committees. This has been a thorough, thoughtful, and collaborative effort that involved a comprehensive survey of committees including a review committee charges, roles, responsibilities and decision-making pathways across committees. We are grateful for the many individuals who participated in shaping and refining our framework.

One key challenge of the previous structure was ambiguity in decision-making processes and the flow of recommendations. The new structure, pictured below, provides a clear framework and path for recommendations:

• **Central Committees** provide recommendations that support the District's mission, goals, and operational plans. These committees hold final recommendation authority on District-wide matters, except where restricted by legal statutes, board policies, or agreements.

• **Operational Committees** serve specialized roles, such as supporting negotiated elements of collective bargaining agreements or addressing institutional functions like technology, facilities, and professional development.

• Academic Senate Consultation Committees function as operational committees focused on professional and academic matters specifically designated for faculty.



To align with this new structure, beginning with the Fall 2025 semester, several committees will undergo changes to clarify responsibilities, prevent overlap, and better align with their areas of focus. Updates include refining charges for clarity; modifying membership to support equitable representation across constituent groups and alignment with the scope of work; aligning with collective bargaining agreements; removing policy and procedure revision responsibilities; and ensuring professional development remains within committees with direct oversight.

## **Committee-Specific Updates**

As a result of this effort, the **District Access Committee** will be dissolved at the conclusion of the Spring 2025 semester. The critical work of the committee will be incorporated into existing committees with the primary oversight of the areas where barriers may occur. This decision reflects the integration of accessibility-related efforts into structures that better align with current operational practices. The committee's facilities-related responsibilities have already transitioned to the District Facilities Advisory Committee (DFAC), while the remaining work—primarily focused on technology and instructional materials—will be integrated into the Institutional Technology Committee (ITC) and Textbook and Instructional Materials Committee (TIMC). As ITG oversees technology across the District and TIMC oversees instructional materials, their charges and committee memberships have been expanded to address accessibility-related responsibilities.

### **Next Steps**

Please share this information with your committee members as soon as possible and thank them for their continued participation. **On Monday, April 7, 2025,** we will send a separate District-wide update on the revisions to the participatory governance structure, noting that chairs have received committee-specific information and will review them with committee members in the coming days.

The final participatory governance structure will be reviewed by College Council on May 15, 2025, for recommendation and approval at the regular meeting of the Board of Trustees on June 10, 2025.
