IV. OPEN COMMENTS – [Kuula – Lewellyn is conducting Arc Flash risk assessment on the SR campus. Reports from Lewellyn will inform SRJC electrician's what type of PPE to wear when working on electrical panels.]

V. OLD BUSINESS

SAFETY SURVEY – Kuula – [Where are we with the safety survey? We did a safety survey in 2013. There was a reorganization of the custodial staff to work more in the evening. Due to the reorganization we now have more than 300 more hours for custodial staff to have access to classrooms and less interactions with people. Switched managers/custodial staff to the evening shift. There were several custodians who wanted to work full-time (they were part-time) and we were able to convert them to the full-time night-time shift. Another aspect of the safety survey was lighting on all campuses. Solar panels will be added to the Santa Rosa Campus parking lots at Emeritus, Bech, and the Zumwalt parking pavilion. Another benefit will be that SRJC will get rebates from PG&E.]

AED UPDATE – [Kuula – Kuula has contacted a company that maintains our AED's. The company does our AED maintenance and does the AED function tests. They also check the AED pads and batteries to make sure they have not expired. The Furniture Fixtures and Equipment committee is working on setting up standards for new buildings to have AED's installed. AED's are costly to purchase and maintain and AED's should be in on every floor. AED's are in the SRJC Police vehicles. The SRJC Adult Education Department sets up our CPR/First Aid/AED trainings. Kuula to bring the AED policy to the next meeting.]

FACILITIES UPDATE – [Bielen – The ELC and Lark expansion portables are being installed. Let Paul know if we see any red flags, near misses. The area near EHS will be a dirt parking lot. Other construction projects are the Barnett Hall replacement and remodel of Maggini Hall 3rd floor.]

EV CHARGING STATIONS [Kuula - Reviewed the car charging station in the parking structure. The charging cord is a trip hazard while being used to charge cars. The charging station is very close to the elevator and is a high traffic area. The committee reviewed a photo of the charging station at the parking structure. Brownlee reported seeing someone charge their car at a light pole (the person had removed the electrical cover off of the light pole to access the plug).]

[Escher – The Santa Rosa Fire Department conducted hazmat inspections today at Bech, Quinn and Trade Technology. There will be a campus wide 6-hour inspection in September. For example, Bech Hall – we would do a wall-to-wall safety inspection which is very challenging and generates a ton of work for facilities. Can we do this a different way? For example, one month we can inspect all areas on campus that have labs. Kuula to draft a document telling departments of what safety issues to look for in their work areas when they do their own inspections.]
